## **LIMITED WARRANTY**

Murray GM Collision Centre hereby provides a Limited Warranty on repairs performed by this shop. This Limited Warranty is valid only for as long as you own the vehicle stated herein, and is for the person to whom this Limited Warranty is granted and whose name appears herein and on the original work order. This is a labor only, fragmented four part Limited Warranty, and stipulations pertaining to each fragmented part are stated hereafter.

1. **METAL WORK:** Murray GM Collision Centre provides a **LIFETIME LIMITED WARRANTY** on all structural metal work, to include welding and the application of material utilized in making collision repairs against cracking, flaking, pitting, or deterioration, excluding rust repairs. The shop will repair and repaint, excluding rust repairs, any metal work warranted hereby, at its sole option, when claim is made while present owner stated herein owns the vehicle, unless caused by or damaged resulting from unreasonable use, maintenance, or care of the vehicle.
2. **PAINTING:** Murray GM Collision Centre provides a **LIFETIME LIMITED WARRANTY** on painting-related priming and painting work against solvent blistering, peeling, hazing and excessive loss of pigmentation, excluding those defects which are caused by extreme environmental conditions to which the vehicle may be exposed (such as rock chipping). The shop will prime and repair the specific section or sections of the vehicle warranted hereby, at its sole option, when claim is made, unless caused by damage resulting from unreasonable use, maintenance, or care of the vehicle.
3. **STRIPES AND DECALS:** Murray GM Collision Centre provides a **TWO (2) YEAR LIMITED WARRANTY** on the application and adhesion of decorative stripes and decals, excluding those defects, which are caused by extreme environmental conditions to which the vehicle may be exposed. The Shop will re-stripe an/or re-decal the specific section or sections of the vehicle warranted hereby, at its sole option, when claim is made within **TWO (2) YEARS** of the effective date shown herein, unless caused by or damaged resulting from unreasonable use, maintenance, or care of the vehicle.
4. **MECHANICAL REPAIRS:** Murray GM Collision Centre provides **One (1) year or 20,000 kilometers, whichever occurs first, LIMITED WARRANTY** on all mechanical repairs pertaining to original collision damage. The shop will repair any mechanical assembly or component warranted hereby, at its sole option, when claim is made within **one (1) year or 20,000 kilometers, whichever shall occur first, of the effective date shown herein, unless caused by or damaged resulting from unreasonable use, maintenance or care of the vehicle. Other parts and components are at distributors warranty.**
5. **PARTS:** Murray GM Collision Centre provides **LIMITED WARRANTY** on new parts installed by our shop. The shop will repair or replace any defective new part warranted hereby, at its sole option, when claim is made within **One (1) year or 20,000 kilometers, whichever shall occur first, of the effective date shown herein, unless caused by or damaged resulting from unreasonable use, maintenance or care of the vehicle. This limited warranty does not exclude any additional warranties that may be offered by the manufacturer or the supplier of the parts replaced. \* Used parts are covered by distributor's warranties\*.**

THIS LIMITED WARRANTY shall be null and void if the repair is altered, adjusted or tampered with by any person not authorized by Murray GM Collision Centre. This warranty is not transferable.

**SPECIFICALLY EXCLUDED** are incidental costs such as towing fees, car rental charges, travel expenses or assemblies and components which are not specifically covered by this LIMITED WARRANTY, nor are consequential damages such as damage to other assemblies and components resulting from a defective part or installation of such part installed or repaired during the repair.

Murray GM Collision Centre is responsible for **only what they repair or replace**, and not for subsequent failure of, or damage resulting from, related parts or units.

HOWEVER this guarantee **does not lessen or replace any rights** a consumer may have under the Saskatchewan Consumer Product Warranties Act.

**This guarantee is subject to** the proof of proper and regular maintenance, as it would relate to the repairs performed. This guarantee does not cover repairs as a result of misuse, or abuse, and does not apply to normal wear and tear, or damage due to environmental factors.

This certificate must be presented for work to be done under this guarantee.

**THIS GUARANTEE IS GOOD ONLY AT MURRAY GM COLLISION CENTRE, UNLESS SO AUTHORIZED BY THEM IN ADVANCE. NO CASH REFUNDS WILL BE MADE WITHOUT PRIOR APPROVAL.**
